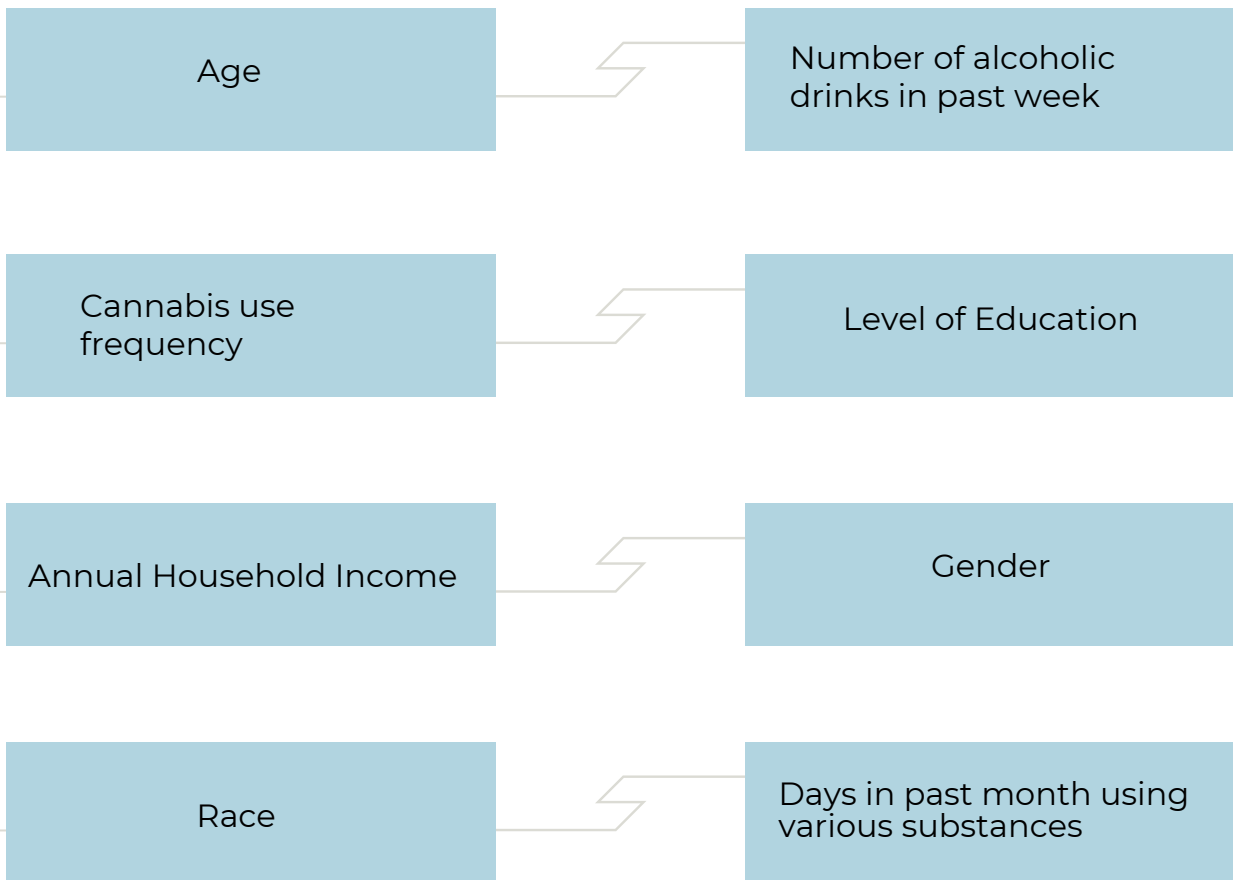

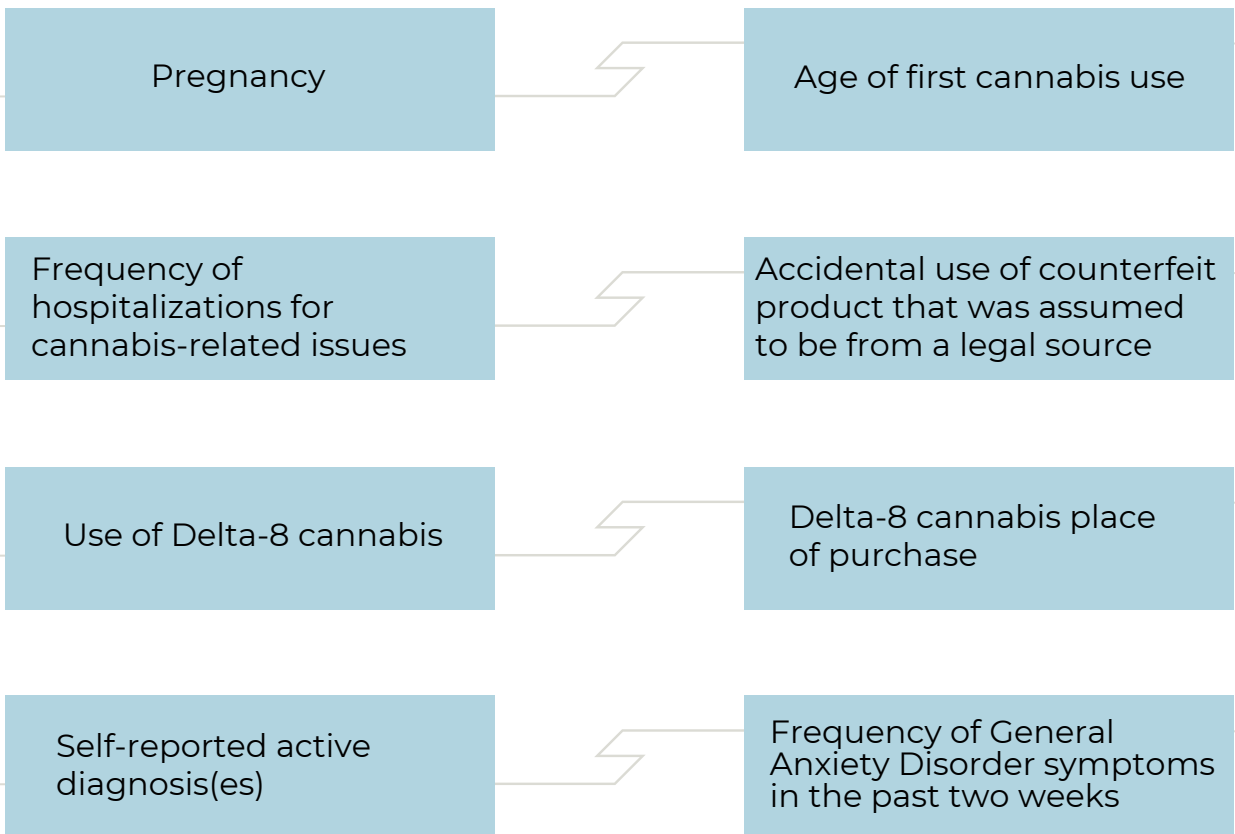

Ease of access to buy illegal cannabis

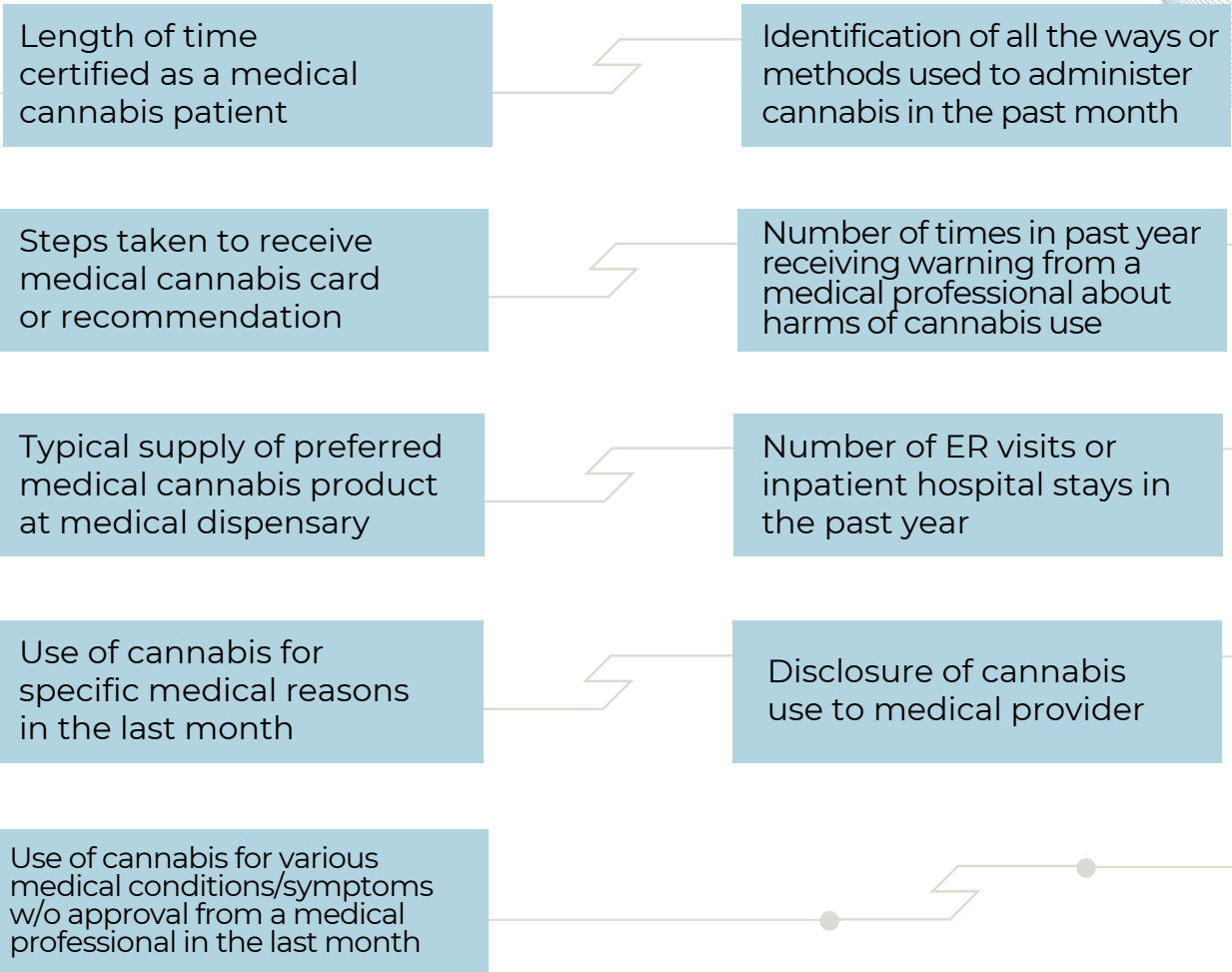

Number of times in past month cannabis advertisements of various forms were noticed

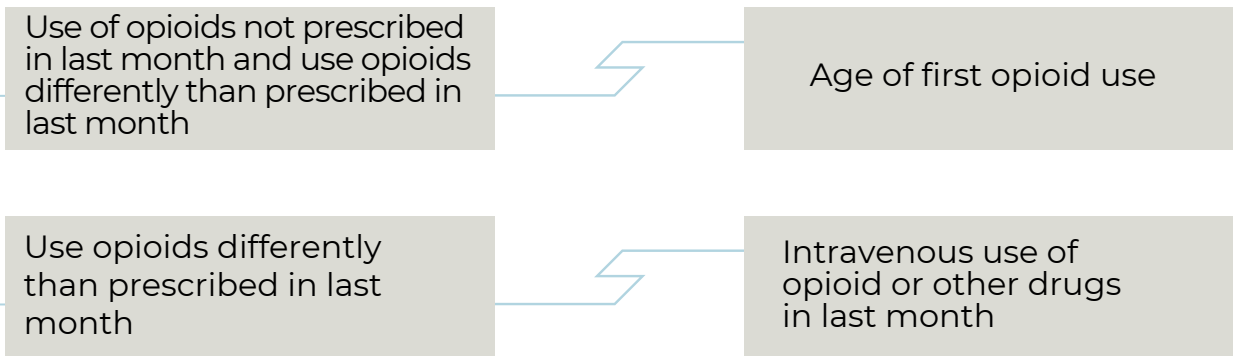
Ease of access to buy legal dispensary cannabis

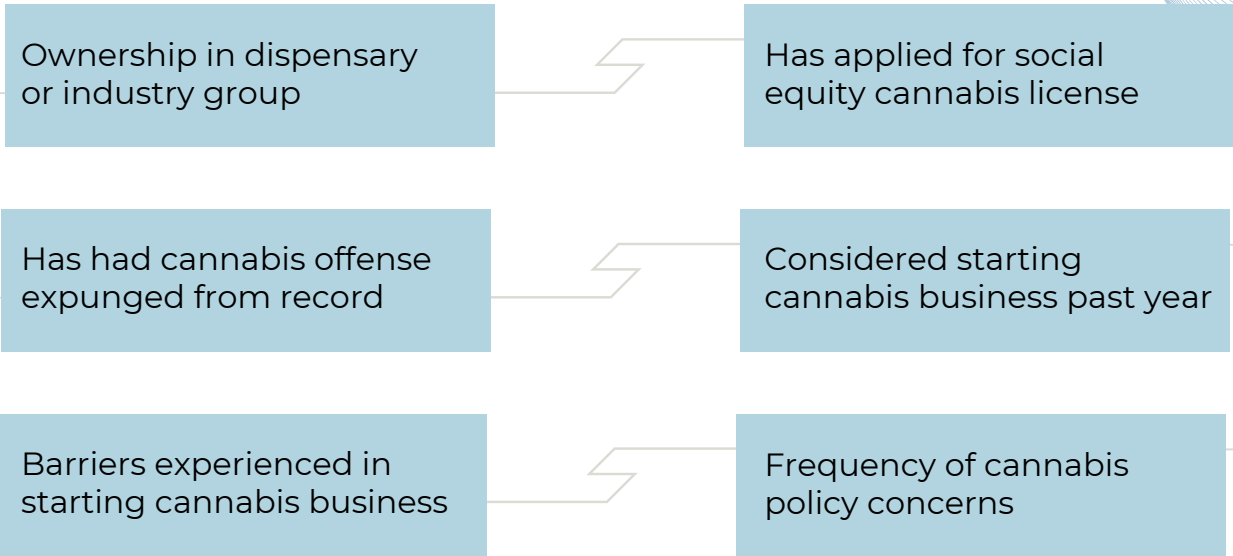
